There are only a few weeks left to claim past Disability Tax Credits before they expire forever. The Income Tax Act has allowed people with disabilities or their caregivers who have not claimed the Disability Tax Credit to reassess their income tax returns back to 1985. But on December 31 the new 2004 federal budget will cut off back filing beyond 10 years. This means that people with disabilities will lose up to 9 years of past tax credits. The Vancouver Dialogue Public Panel Symposium will feature the following distinguished guests. They will explain how they see the role of such international justice institutions in the larger context of post conflict peace building:

1. ? Mr. Bruno Cathala, Registrar, The International Criminal Court, The Hague, Netherlands
2. ? Mr. Robin Vincent, Registrar, Sierra Leone Special Court, Freetown, Sierra Leone
3. ? Mr. Alan Kessel, Director General, Legal Affairs Bureau, Foreign Affairs Canada

Some of the most important questions being asked today involve the role and importance of justice institutions such as the International Criminal Court (ICC) in post conflict peace-building.

Is it more important to bring perpetrators of genocide, war crimes and crimes against humanity to justice to bring "closure" to a conflict and for its deterrent effect? Or is it better to use any means to end a conflict, even an amnesty? Is seeing justice done more likely to help the healing process and enable a society to recover, or does it re-open wounds and prolong social divisions? Should the notion of international justice institutions be restricted to courts and tribunals, or also include alternative mechanisms, such as truth-finding commissions and traditional remedies? Could the resources spent on bringing justice to a post conflict society be better spent on other reconstruction efforts such as, rebuilding the country's legal institutions?

No One is Illegal Vancouver, along with other defenders of immigrant and refugee rights, will be continuing the fight to repeal the racist Security Certificates process.

This measure has been used to indefinitely detain, without charge, 5 Muslim men in the post 9/11 climate. They remain detained without charge or bail on secret evidence neither they nor their lawyers are allowed to see, in Montreal, Ottawa and Toronto. They have been behind bars anywhere from 18 months to over four years, denied a fair trial, and are at risk of deportation to torture.

The families of these men and their supporters are calling for a CROSS-CANADA DAY OF ACTION on FRIDAY 10 DECEMBER to demand FOUR things:

1. That the five men be released immediately; or, if any case against them actually exists, that they be allowed to defend themselves in open, fair and independent trials with full disclosure of the case against them.
2. That they not be deported.
3. That the federal government abolish the secret trial security certificate process.
4. That CSIS, RCMP, and CIC end its ongoing harassment and intimidation of individuals and communities of Arab, Middle Eastern, and South Asian heritage and/or Muslim faith.

On International Human Rights Day, December 10, which is also the second anniversary of the detention of one of the Secret Trial Five, protests will be happening in about ten cities in Canada.

The attacks on the dignity and rights of these men is part of a much broader attack on refugees and immigrants, and very specifically Muslim, Arab, and South Asian communities.

And many of those immigrants and refugees who courageously fight back against the government policies of repression have been swiftly detained, deported, viciously beaten, consistently intimidated and threatened: the deportations of Operation Threadbare victims, the brutal beatings of

non-status Algerians and supporters, and the string of deportations of immigrants and refugees who have been fighting back. Supporters such as Justin Goodman in Vancouver have been prosecuted and sentenced, while others around the country face pending trials. But we will continue to fight.

## 12. JUSTIN GOODMAN SENTENCED TO 90 DAYS

This morning, in B.C. Supreme Court, Justin Goodman was sentenced to 90 days in jail for his role in an anti-deportation action at Vancouver Airport almost 2 years ago. Previously, Justin had been convicted of "assault on a peace officer" and "assisting escape from 'lawful' (sic) custody" (an additional charge of "obstruction" was stayed).

In sentencing Justin to the full 90 days recommended by the Crown Prosecutor, the Judge cited the "deterrence" & "denunciation" principles of the Criminal Code: in other words, acts of solidarity and sympathy must be "denounced" and "deterred" through the imposition of criminal sanctions serious enough to cause others to think twice before engaging in similar acts of decency. The Judge also said, with a straight face,

that violations of the "rule of law" undermine "legitimate social protest."

At the adjournment of court, most people remained sitting when the Sheriffs ordered everyone to stand. A few of Justin's comrades shouted messages of support as he was led away.

Many people went to the Airport that day to try to prevent the deportation of Iranian refugee Kobra Nateghi and her young adult son, Hassan (whose anxiety attack on board the airplane deporting him was referred to as a "violent outburst" by the Crown!). Justin is paying the price for an action that, although ultimately unsuccessful in preventing Kobra and Hassan from being deported, inspired many of us by demonstrating that when poor and marginalized people are under attack by the state, we have a responsibility to defend them (according to a recent article in "The Only" magazine, members of the Iranian community in Vancouver have not heard from Kobra in over a year).

Please support Justin in any of the following ways:

1. Write Justin a letter or, even better, visit him in prison (according to Courthouse staff, prisoners are taken to the "Pre-Trial Centre" in Port Coquitlam before "Corrections" staff decide the provincial jail where they will be sent - I will attempt to find out his location and contact details within the next few days).
2. If you have any spare \$\$\$, please donate whatever you can to help Justin cope with his time in jail: prisoners need money for phonecards, extra food, personal items, etc. (again, I am looking into the easiest and most efficient way to get the money to Justin and will report back in a few days).
3. Don't stop organizing and fighting back! - As our resistance intensifies, so will the repression; if we let our (completely understandable) fear stop us from acting, our enemies win!
4. Support groups such as "No One is Illegal - Vancouver" & the "Land, Freedom and Decolonization Coalition" which are fighting against deportations, racial profiling, and for the rights of immigrants,

refugees, Indigenous communities and other poor and marginalized people.

5. Finally, support other comrades and members of our community who are under attack - attend court appearances, donate to legal defence, organize fundraisers, do legal defence or other support work, educate yourself and others about the real nature of our "criminal (in)justice" system; do not publically denounce or attack other militants and activists as this only plays into the hands of our enemies (although constructive "in-house" debates help our movement to grow).

## 17. ABOUT JOHN GRAHAM

Hello all,

As many of you may know, December 6 was the first day of extradition hearings for John Graham. In the morning prior to court, John was feeling some stress, but was also very positive to be walking the path of truth. He was surrounded my many friends and family members, some from the local area and others who flew in to Vancouver to observe the hearings and offer their support.

During this first day, John's lawyers reviewed the details of his arrest, about how he was first detained for a false accusation of harassment. While in police custody on this charge, John was allowed to contact a lawyer -- which he did. After this call however, John was then informed of a new charge relating to the US indictment for the murder of Anna Mae Aquash. The original complaint evaporated, and was replaced solely by this new charge. After being informed of the new charge, John was not

allowed to contact legal counsel -- an apparent violation of his rights -- and was further interrogated.

One witness which the defence called to testify was a woman employed at the local police detachment where John is required to check in on a daily basis. Not only has John checked in consistently and reliably, but he had also made friends of the staff and has sold one of his hand-crafted willow chairs to an employee. John has been crafting such items to subsidize his income, since the restrictions of house arrest make it nearly impossible to find other employment.

Another development recently was the issuing of a statement by Leonard Peltier (included below) about the matter of John Graham, which is included below.

Peltier Statement on Graham Extradition Hearing  
December 6, 2004

Today, the U.S. government will seek John Graham's extradition to stand trial in South Dakota for the murder of Anna Mae Pictou Aquash. I urge all of you to closely monitor the proceedings and ensure that Canadian authorities thoroughly examine all the evidence presented by the U.S. government in this case.

Never forget the role of U.S. law enforcement officials in incidents that took place in the 1970s on the Pine Ridge Indian Reservation. The Federal Bureau of Investigation (FBI) tirelessly tried to prejudice the fair trial rights of American Indian Movement leaders charged with serious crimes during that turbulent period and knowingly presented false evidence to illegally obtain my extraction from Canada in December 1976.

You may be thinking "That was then, this is now." Yes, many things have

changed since the 1970s, but one thing has not changed, I assure you: Indians in the U.S. continue to struggle against the most dangerous, well-funded, strongest military and political organization in the world. I know the behavior of the FBI and other government officials has not changed. I fear that Graham will not receive a fair hearing in Canada or a fair trial in the U.S., anymore than I did.

To the Canadian officials I say, justice cannot be achieved if a full investigation into the FBI's role in Annie Mae's death is not included in the inquiry. Annie Mae's death was the direct result of the FBI's activities on Pine Ridge. The FBI told Anna Mae that they would see her dead within a year if she did not cooperate with them, used their puppets to spread rumors that Annie Mae was an informant when she refused to cooperate, and mishandled the investigation of her death. Your investigation must consider the fact that the FBI's pathologist listed the cause of her death as exposure, despite the obvious bullet hole in her head, and Annie Mae's quick burial before a positive identification could be made.

Your investigation also must include examination of FBI Special Agent David Price who was very familiar with Annie Mae's appearance and saw her body after it was first recovered, yet failed to identify her. I believe he attempted to cover up her murder. When this was no longer possible, due to the findings of an independent pathologist, the FBI issued a false press release implying that some of her own people murdered Annie Mae because they believed she was an informant. Look for and find the truth. In so doing, remember that officials of the U.S. violated your sovereignty in 1976 by deceiving your courts and using you to wrongfully convict an innocent man. Remember. And be vigilant. The First Nations of the U.S. and Canada want justice for Anna Mae, but also do not want an injustice done in her name.

**18. ABOUT THE AGRICULTURAL LAND RESERVE**

Removing Abbotsford farmland from Land Reserve mistaken, says SPEC.

?The ALR (Agricultural Land Reserve) is not meant as a reserve to compensate for poor land-use planning,? said SPEC Director Carole Christopher. ?If land is taken out of the ALR and used for development, there is no incentive for smart growth. Giving agricultural land over to development invites poor land-use decisions and very shortly will re-create the same need for more exclusions on a grander scale. ?

Christopher?s comments are part of a SPEC submission to ALR head Kirk Miller who is overseeing an application by the City of Abbotsford to remove 900 acres of prime farmland from the ALR over the next two decades, and use it for industrial development..

The parcels under consideration in the current application include Class 1 land; almost all of it prime farmland. The general region around Abbotsford is special in its soil conditions and provide excellent drainage and good topsoil. It is one of the three best areas for growing raspberries in the world. As well, these soils are suitable for growing a wide range of crops with high production levels.

According to a study by SmartGrowth BC, only 17 per cent of industrial floor space in Abbotsford is currently being used. By comparison the average of industrial use in the GVRD is 50 per cent. If Abbotsford approached the levels of use in the GVRD, it could almost triple its industrial lands without removing more farmland from the ALR.

The ALR was formed in 1973 to preserve scarce agricultural land in BC. Since then it has become a model for other jurisdictions. But it has also come under intense pressure from developers and municipalities eager to expand their residential and industrial base. While Abbotsford farm land fetches about \$25,000 per acre, a landowner could sell the same piece for up to \$300,000 as an industrial site.

?It was a wise decision to put land aside in the ALR,? said Christopher. ? Given the potential for food insecurity in the future, the ALR is a precious reserve and the precautionary principle should be first and foremost in the minds of commissioners.?
