1. BLACK HISTORY MONTH

Did you know that:

Canada has its own history of slavery, segregation and discrimination of and against Blacks? Sir James Douglas, British Columbia's first governor was of mixed heritage born of a Black mother and Scottish father?

In the 1850's Vancouver Island was under threat of being annexed by the U.S. and this was prevented in part by the immigration of several hundred free Blacks from the U.S. to Vancouver Island at the invitation of Sir James Douglas? Not all Blacks who immigrated to Canada were escaped slaves on the Underground Railroad? During the 1868 Yale Convention, a Black man, Mifflin Wistar Gibbs, was instrumental in debating British Columbia's joining the confederation of Canada rather than annexation to the U.S.? The first school in South Saanich was built by a Black man, Charles Alexander who was also active in the building of Shady Creek Church the first church in South Saanich? Many of the first Blacks to British Columbia were businessmen and women, some first teachers, lawyers and dentists? Vancouver Island's first law enforcement organization was a Black militia known as the Victoria Pioneer Rifles (African Rifles)?

The first teacher of the Cranberry? Cedar school near Nanaimo was a Black woman by the name of Emily Stark? A Black teacher John Craven Jones taught school on Salt-Spring Island being paid only in kind by the pioneer families? In 1886 a Black dentist William Allen Jones was the first person to register under the British Columbia Dental act? A Black Canadian doctor, discovered a process for storing plasma? Deas Slough, (near the George Massey tunnel in Vancouver) is named after a Black man John Sullivan Deas who was a leader in the early years of B.C.'s salmon canning industry? A Black man Harry Winstone Jerome world-renowned athlete, founded the Premier Sports Awards Program used by many provincial school districts? These are just a few of the accomplishments and contributions of British Columbia's Black Community. 2. OPEN-PIT CYCANIDE LEACH GOLD MINE IN GUATEMALA

Thousands of indigenous villagers in Guatemala are protesting an open-pit cyanide leach gold mine. The Marlin gold mine is being developed by the Canadian-U.S. firm Glamis Gold in the

western Guatemalan highlands. Starting last December, villagers in the neighboring province blockaded trucks carrying mining equipment for 40 days. One villager died and many others were injured when the Guatemalan government sent in the military in mid January to end the blockade.

The International Finance Corporation of the World Bank approved a \$45 million loan for the Marlin project in June 2004. The IFC did not first check to see if the local population supported the development of the mine. In fact, Guatemala's National Council of Indigenous Peoples has publicly called on the government to reject the project. Villagers say that Glamis Gold has failed to consult directly with them, and failed to inform them about environmental risks and impacts.

Take Action!

Subject: Stop the Marlin mine until indigenous villagers give their consent

Dear [decision maker name automatically inserted here],

I am writing to express serious concerns about Glamis Gold's proposed Marlin gold mine which has recently been the focus of large-scale protests by local indigenous peoples in the western highlands of Guatemala.

The affected populations say that they lack critical information about the project, including potential environmental risks, and that they have not consented to the development of the mine. In fact, they question whether this project will bring real benefits to them. January 11th marked the fortieth day of protest and the villagers' blockade of trucks carrying mining equipment. The Guatemalan government's decision to send in military troops to end the 40-day blockade of trucks carrying mining equipment resulted in the death of at least one villager and many injuries. This is tragic and disturbing and raises even greater concerns about the lack of dialogue and engagement with the community.

The Marlin project has the backing of the International Finance Corporation (IFC), which approved a \$45 million loan in June 2004 even though Guatemalan groups were cautioning that large segments of the local population did not support the project and were calling for increased consultation. IFC should recall that the World Bank management stated, in response to the Extractive Industries Review, that it would only support mining projects that enjoyed "broad community support." Current developments suggest this is not the case with the Marlin project. In support of the local communities and indigenous rights, I ask that:Glamis Gold engage in open and transparent dialogue with all potentially affected communities and halt further development of the mine until community concerns are addressed and full respect for the rights of affected communities can be guaranteed.The IFC suspend further processing of the loan and support the dialogue between the communities, the company, and the government. IFC should also insist on the establishment of an independent and thorough review of the project, including a complete environmental impacts assessment, an independent audit of the company's

"consultation" with communities, and a review of the events leading to violence on January 11th.

The IFC visit the communities to be impacted by the project, along with conflict resolution specialists, and that they coordinate their visit with local NGOs and communities directly.

3. A PLACE TO LIVE

Some years ago, when I worked in London UK as a holistic careers consultant, I discovered that three things would prevent a person from being able to visualize a clear pathway to fulfilling work. They were (1) not having a secure place to call home, (2) needing to work with a therapist to end self-sabotage, and (3) needing a holiday. Those of us who have a place we call home are very fortunate. Here in the Capital Region, there are 22,000 families for whom their housing is either unaffordable, too small, or a threat to their health. There are others who have no home at all. Our housing shortage is critical, and our rental vacancy rate of 0.6% is the lowest in Canada, meaning it's the toughest in which to find a place to live. If you are one of the many who can only find limited income, finding any housing, let alone good housing, is tough. Behind all this, there's these daunting facts: in 1973, the 10% richest families in Canada had 21 times more income than the 10% poorest families. In 1996, they had 314 times more. (All my facts come from the Community Council's Quality of Life Challenge). So what's the solution? The answer is to establish a Regional Housing Trust Fund, a stable, annual \$1 million fund that could be used to leverage private investment dollars and build affordable homes similar to those established in Edmonton, Calgary and Winnipeg, and in Langford, Colwood, Richmond, Whistler, Vancouver, Kelowna, Surrey and North Vancouver. This proposal is before our municipalities right now: all that it needs is your support. If you believe in the need for our world to be more just, and more kind, please call your local councillor. Yes, it means we would pay a small tax increase; sustainability means nothing if we can't support our own.

There is a serious situation developing at the Fernwood Community Association which I feel the Victoria public and especially Fernwood residents should be informed of. A group of people mainly from the Fernwood Community Center - FCC are attempting a takeover of the Fernwood Community Association - FCA.

The FCC folks have taken out a large number of FCA memberships and are on the verge of pulling off a hostile merger (takeover) of the FCA which I feel threatens the FCA's political independence and the FCA building. There are strong rumours that a post merger FCC controlled board may mortgage the FCA building.

The present FCA Board is 100% against this takeover but the pro-FCC people have called for a Special General Meeting, which will happen in the next few weeks, at which time a vote will take place to force the FCC-FCA "merger".

If someone wants to have some input and vote at that meeting they have to take out a FCA membership within the next week to 10 days (before approximately Feb. 15th).I'm the first person to admit that the FCA is not perfect and is not fulfilling it's role as a neighbourhood advocacy center but this takeover could be the end of any and all FCA advocacy work entirely. The membership requirements for the FCA are that you have to live, work, study or volunteer in Fernwood (inside Hillside, Quadra, Fort, Shelbourne). Memberships are \$5. 6. THE STRUGGLE OF ALFREDO PORRAS

Refugee Trade Union Leader to Speak

Colombian Trade Union leader Alfredo Porras will speak and show a video on

Thursday, February 10th at 7:30 pm at Malaspina University College in Bldg 355 Rm 203.

Alfredo will share a part of the Coca Cola story which Coca Cola would rather not have us know.

The struggle of Alfredo Porras Alfredo Porras was a Coca Cola worker in Colombia for 20 years.

He worked for a long time as Union leader where he was a key negotiator of worker's collective agreements. He worked on Human Rights issues and delivered humanitarian help for the

people displaced by the war. In 1997 the Colombian army started a campaign of harassment

against him including a movie like raid to his home in October of the same year. In January 1998

there was an attempt to assassinate him. The army alleged he was a Financial Chief of the ELN

guerrilla group and Alfredo learnt that he had been declared a military object. He fled to Chile

with help of an ONG and came back after one year to find more persecution This increased

even more after President Alvaro Uribe won the election. On December 31/02 Alfredo was

arrested by the army. The media portrayed this case as a major blow to the guerrilla group. The

case went to a special prosecution due to the importance and attention given to it in the media.

The Special Prosecution declared that the charges were unfounded and dropped all of the

charges as there is no proof that Alfredo was a rebel or that he had any involvement with the

guerrilla group. The prosecution declared that he has been framed by the army. Despite the

prosecution verdict, the army's 2004 report presented at the end of the year stated that the

Financial Chief of the ELN was Alfredo Porras and that he was to be captured. After seeing this

report Canada gives immediate asylum to Alfredo. He lives in Vancouver with his 10 year old

daughter, 8 year old son and wife. They came to Canada in May 2004. Alfredo will speak about

the struggle of the unions in Colombia, specifically the Coca Cola Union, and the violation

against its members and workers. He will also speak about the price workers pay for

globalization and the tragic toll paid by families and communities.
